The Syracuse Regional Airport Authority (SRAA) hereby submits its Annual Report for FYE 2012. The SRAA was established in August 2011. The SRAA has not yet assumed control of the operation or management of Syracuse Hancock International Airport, including employees and the aviation enterprise fund. As a result, some of the required policies and procedures have not been established. Work towards a Lease and Management Agreement continues, with the transition tentatively scheduled to occur January 1, 2014.
