### Report on the Financial Statements

We have audited the accompanying statements of net position of the Town of Colonie Industrial Development Agency (Agency) as of December 31, 2014 and 2013, and the related statements of revenues, expenses, and changes in net position, and cash flows for the years then ended, and the related notes to the financial statements.

### *Management's Responsibility for the Financial Statements*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

### *Auditor's Responsibility*

Our responsibility is to express an opinion on these financial statements based on our audits. We conducted our audits in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States. Those standards require that we plan and perform the audits to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### *Opinion*

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the Town of Colonie Industrial Development Agency as of December 31, 2014 and 2013, and the changes in its financial position and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

**Other Matters**

*Required Supplementary Information*

Accounting principles generally accepted in the United States of America require that management's discussion and analysis on pages 3 through 7 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audits of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

*Supplementary Information*

Our audits were conducted for the purpose of forming an opinion on the Agency's basic financial statements. The schedule of indebtedness is presented for purposes of additional analysis and is not a required part of the basic financial statements. The schedule of indebtedness is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the basic financial statements. Such information has been subjected to the auditing procedures applied in the audits of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the schedule of indebtedness is fairly stated, in all material respects, in relation to the basic financial statements as a whole.

**Other Reporting Required by Government Auditing Standards**

In accordance with *Government Auditing Standards*, we have also issued our report dated February 23, 2015, on our consideration of the Agency's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the Agency's internal control over financial reporting and compliance.

## Management's Discussion and Analysis December 31, 2014 and 2013

The following Management's Discussion and Analysis (MD&A) provides an introduction and overview to the financial activities and performance of the Town of Colonie Industrial Development Agency (Agency) for the years ended December 31, 2014 and 2013, as mandated by Governmental Accounting Standards Board Statement No. 34. This information should be reviewed in conjunction with the financial statements of the Agency.

### Overview of Financial Statements

The Agency's financial statements are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) promulgated by the Governmental Accounting Standards Board (GASB). The Agency is structured as a single enterprise fund with revenues recognized when earned, not when received. Expenses are recognized when incurred, not when they are paid. Capital assets are capitalized and are depreciated over their useful lives. See notes to the financial statements for a summary of the Agency's significant accounting policies.

The *Statements of Net Position* present information on the Agency's assets and liabilities, with the difference between the two reported as net position. Over time, increases or decreases in net position may serve as a useful indicator of the Agency's financial position.

The *Statements of Revenues, Expenses, and Changes in Net Position* present information showing how the Agency's net position changed during the most recent years. All changes in net position are reported as soon as the underlying event giving rise to the change occurs, regardless of the timing of related cash flows. Thus, revenues and expenses are reported in these statements for some items that will result in cash flows in future periods.

The *Statements of Cash Flows* relate to the flows of cash and cash equivalents. Consequently, only transactions that affect the Agency's cash accounts are recorded in these statements. A reconciliation is provided at the bottom of the statements of cash flows to assist in the understanding of the difference between cash flows from operating activities and operating income.

In addition to the financial statements and accompanying notes, this report also presents the *Supplemental Schedule of Indebtedness*.

### Financial Highlights

- The Agency's net position decreased \$78,796 from December 31, 2014 to 2013, as compared to a decrease of \$648,623 from December 31, 2013 to 2012. This substantial decrease is the direct result of public benefit projects undertaken by the Agency during 2013 (see table on page 6). 2013 projects include expansion of water lines in the Railroad Avenue corridor, completion of the Mohawk River Landing Park and Winding Creek Bike Path projects, and installation of sidewalks along a portion of the Route 9 corridor. In 2014 no new projects were undertaken, and the only project cost was related to the completion of the Mohawk River Landing Park project.
- The Agency was presented with several projects during 2014, but they are still within the planning phases or were declined, and therefore, have generated no administrative fee revenues. The fees collected by the Agency in 2014 were related to a revised cost estimate for the Shelter Cover project. The other revenues related to a \$10,000 grant received related to the Mohawk River Landing Park project and \$13,548 received from forfeited developer deposits related to the Winding Creek Bike Path project.

### Financial Highlights - Continued

- As part of the Route 9 sidewalk project, the Agency advanced the Town of Colonie \$400,000 in 2013 to fund the required New York State deposit. This deposit was returned to the Agency in 2014 upon completion of the project.
- The Agency, under an agreement with the Albany-Colonie Regional Chamber of Commerce, continues to maintain the Town of Colonie Small Business Entrepreneurial Loan (SBEL) Program. In 2014, the Agency paid \$1,098 to the Albany-Colonie Regional Chamber of Commerce for management of this program and at December 31, 2014, the program had a net loan receivable balance of approximately \$40,000.

The overall decrease in net position from 2012 to 2014 is the result of the Agency's efforts to support economic development within the Town of Colonie, as mandated by New York State Law.

Current assets decreased \$158,948 at December 31, 2014, compared to an decrease of \$554,474 at December 31, 2013, while non-current assets increased \$18,359 at December 31, 2014, compared to a decrease of \$45,316 at December 31, 2013.

### Financial Analysis of the Agency - Continued

In 2014 the decrease in current assets resulted from normal operating expenses of the Agency, with no significant economic development activities, as in 2013 and 2012, resulted in an operating deficit of \$81,678. Current assets within the SBEL program decreased \$24,159 with the issuance of \$25,000, net, of new loans in 2014. During 2014 the Chamber and Agency determined it appropriate that one of the loans should be written off against a previously established allowance in the amount of \$16,457 and to establish a reserve for doubtful accounts based on the SBEL program's historic collection experience in the amount of \$6,232.

Accounts and accrued payables decreased \$61,793 at December 31, 2014, due to the timing of the payments of certain economic development costs incurred for 2013.

### Activities for the Years Ended 2014, 2013 and 2012

The Agency's annual fees for services are tied to the size and timing of economic activity projects. These fees increased by \$20,000 in 2014 as compared to none in 2013. This was a result of a cost revision to a project approved in 2012 and not the result of new projects in 2014. The Agency was presented with several projects during 2014, but they are still within the planning phases and, therefore, have generated no administrative fee revenues. The table below presents a summary of the administrative fee revenue for the years ended December 31, 2014 to 2010.

Interest earnings decreased in 2014 by \$3,648 as compared to a decrease of \$2,809 in 2013. The decrease in interest income is principally due to lower cash balances for much of 2014, in addition to lower interest rates, as compared to 2013. Additionally, the Small Business Entrepreneurial Loan Program continues to generate less interest income as loans are paid off and not replaced by new issuances.

Administrative expenses increased \$6,766 in 2014 as a result of the pre-demolition studies related to the vacant building owned by the Agency. Economic development costs for both 2014 and 2013 include fees the Agency paid related to the enhancements of the Planning and Economic Development Department and Small Business Advisory Council pages linked to the Town of Colonie website to facilitate interaction within the commercial development process.

Professional fees remained stable during 2014, with only a \$1,832 increase due to minor increases in auditing and legal fees. Public benefit project costs decreased in 2014 by \$506,719 as compared to an increase of \$292,711 in 2013. The table below presents a summary of the public benefit project costs for the years ended December 31, 2014 to 2010.

## **Activities for the Years Ended 2014, 2013 and 2012 - Continued**

Management and administrative fees are paid to the Town of Colonie and Albany-Colonie Chamber of Commerce, respectively, under service agreements and remained stable in 2014, decreasing by \$571 from 2013. The bad debts expense is related to the SBEL program and is the result of establishing a general reserve for uncollectible loans in the amount of \$6,232 in 2014.

Depreciation expense decreased about \$7,000 because the capital assets are primarily the vacant building noted above, for which the Agency recognized an impairment loss in 2013, bringing the carrying value to zero. The remaining depreciable capital asset is the development costs for the Agency's website and will be fully depreciated in 2015.

## **Note 1 - Organization and Summary of Significant Accounting Policies**

### *a. Organization and Purpose*

The Town of Colonie Industrial Development Agency (Agency) was created in 1977 by the Town of Colonie (Town) under the provisions of Chapter 232 of the 1977 Laws of New York State for the purpose of encouraging growth in the Town. The Agency is exempt from federal, state, and local income taxes. The Agency, although established by the Town, is a separate entity and operates independently of the Town. Agency members have complete responsibility for management of the Agency and accountability for fiscal matters. The Town, the Agency, nor any political subdivision thereof, is obligated in any manner for repayment of bonds issued by the Agency. Accordingly, the bonds are not reported as liabilities in the accompanying financial statements.

### *b. Basis of Accounting and Financial Statement Presentation*

The accounts of the Agency are maintained in a single proprietary fund on the economic resources measurement focus and the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) for government entities. The Governmental Accounting Standards Board (GASB) is the primary standard-setting body for establishing governmental accounting and financial reporting principles. With this measurement focus, all assets and liabilities associated with operations are included on the statement of net position.

Net position is presented in the following categories:

*Invested in capital assets* - Consists of capital assets, net of accumulated depreciation.

*Restricted for revolving loan fund* - Consists of net loans receivable, accrued interest earnings, and a cash account restricted for use by the Revolving Loan Fund (Note 6).

*Unrestricted* - Consists of all other net position that do not meet the definition of "invested in capital assets" or "restricted for revolving loan fund."

### *c. Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting year. Actual results could differ from those estimates.

### *d. Receivables*

Receivables consist of administrative fees receivable and Small Business Entrepreneurial loans. Administrative fees receivable are carried at original invoice amount. Management considers these receivables to be fully collectible; accordingly, there is no allowance for doubtful accounts.

### d. *Receivables* - Continued

Loans are carried at amortized amounts, based on paydown of principal. Management records an allowance on loans based on a review of the outstanding loan balances and its collection history. At December 31, 2014 and 2013, the allowance for uncollectible loans receivable was \$6,232 and \$16,825, respectively. The allowance is reviewed annually based on collection history of the loans and known facts and circumstances.

### e. *Capital Assets*

Capital assets acquired by the Agency are stated at cost including interest capitalized during construction when applicable. Depreciation is recognized on a straight-line basis over the estimated useful lives of the assets.

Restricted cash consists of funds held for use in the Agency's revolving loan fund. The Agency's investment policies are governed by State statutes. Permissible investments include obligations of the U.S. Treasury and U.S. agencies, repurchase agreements, obligations of New York State or its localities, and Certificates of Participation.

### Note 2 - Cash - Continued

In accordance with the provisions of Section 10 of the General Municipal Law of New York State, all Agency deposits, including certificates of deposit and special time deposits in excess of the amount insured under the provisions of the Federal Deposit Insurance Act, shall be collateralized by a pledge of eligible securities, letters of credit, or surety bonds. As of December 31, 2014 and 2013, the collateral was sufficient to secure the Agency's deposits in excess of FDIC insurance.

The written investment policy requires repurchase agreements to be purchased from banks located within the State and that underlying securities must be obligations of the federal government.

All investment obligations shall be payable or redeemable at the option of the Agency within such times as the proceeds will be needed to meet expenditures for purposes for which the monies were provided and, in the case of obligations purchased with the proceeds of bonds or notes, shall be payable or redeemable at the option of the Agency within two years of the date of purchase.

### Note 4 - Related Party Transactions

Transactions with the Town are as follows:

The Comptroller's Office and the Department of Planning and Economic Development of the Town provide staff support and office space to the Agency. Under the terms of an annual agreement, the Agency paid the Town \$57,174 and \$56,013 for support services for the years ended December 31, 2014 and 2013, respectively. The Agency also reimburses the Town for direct costs incurred by the Town on behalf of the Agency.

## **Note 4 - Related Party Transactions - Continued**

During 2013, the Agency entered into a grant agreement with the Town related to an agreement the Town entered into with the New York State Department of Transportation under a multi-modal program capital project agreement for the construction of a sidewalk along the east side of Route 9. Under the grant agreement, the Agency advanced a total of \$491,000 to the Town to be placed on deposit with the New York State Comptroller's Office. The Agency initially recorded the \$400,000 as due from the Town. The remaining \$91,000 was recorded as a public benefit project expense and represents the Town's portion of the estimated project costs which were previously agreed to be funded by the Agency. The \$400,000 was returned to the Agency from the Town in September 2014 upon completion of the project.

## **Note 5 - Industrial Revenue Bond and Note Transactions**

Industrial development revenue bonds, notes, and straight leases issued by the Agency are secured by property which is leased to companies and is retired by these payments. The bonds, notes, and straight leases are not obligations of the Agency or the Town. The Agency does not record the assets or liabilities resulting from bonds, notes, and straight leases issued in its accounts, since its primary function is to arrange the financing between the borrowing companies and the bonds, notes, and lease holders, and funds arising there from are controlled by trustees or banks acting as fiscal agents. For providing this service, the Agency receives administration fees from the borrowing companies. Such administrative fee income is recognized upon issuance of bonds, notes, and leases. There were no new issuances of industrial revenue bonds during 2014 and 2013. The Agency had industrial revenue bonds outstanding totaling \$6,590,000 at both December 31, 2014 and 2013.

## **Note 6 - Revolving Loan Fund**

### *Commitments and Contingencies*

The Agency established the Town of Colonie Small Business Revolving Loan Trust Fund (Fund), which is administered by the Albany-Colonie Regional Chamber of Commerce (Chamber) for the purpose of providing loans to qualified small businesses. The Chamber is authorized and empowered to make loan commitments not to exceed \$25,000 to a single qualified borrower and to advance loan proceeds from the Fund. The Agency pays the Chamber an administrative fee, from interest income, for its services in connection with the Fund. Any and all other interest earned by the Fund becomes part of the principal of the Fund to be used to make additional loans. Principal payments from borrowers are also returned to the Fund.

During 2014, the Fund issued a term loan of \$25,000 and \$10,000 on a previously established line-of-credit. No loans were issued during 2013. The Fund received principal payments of \$9,756 and \$38,687, together with payments for interest of \$2,196 and \$3,110 during 2014 and 2013, respectively. Administrative fees of \$1,098 and \$1,555 during 2014 and 2013, respectively, were paid to the Chamber. At December 31, 2014 and 2013, the Chamber held \$39,607 and \$20,227 in loans receivable, net of allowance, in trust for the Agency. See Note 1.d. for the allowance for uncollectible loans.

We have audited, in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States, the statement of net position of the Town of Colonie Industrial Development Agency (Agency) as of December 31, 2014, and the related statements of revenues, expenses, and changes in net position, and cash flows for the year then ended, and the related notes to the financial statements and have issued our report thereon dated February 23, 2015.

**Internal Control Over Financial Reporting**

In planning and performing our audit of the financial statements, we considered the Agency's internal control over financial reporting (internal control) to determine the audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Agency's internal control. Accordingly, we do not express an opinion on the effectiveness of the Agency's internal control.

A *deficiency in internal control* exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A *material weakness* is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected on a timely basis. A *significant deficiency* is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Our consideration of internal control was for the limited purpose described in the first paragraph of this section and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

**Compliance and Other Matters**

As part of obtaining reasonable assurance about whether the Agency's financial statements are free from material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the determination of financial statement amounts. However, providing an opinion on compliance with those provisions was not an objective of our audit, and accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards*.

**Purpose of this Report**

The purpose of this report is solely to describe the scope of our testing of internal control and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the Agency's internal control or on compliance. This report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the Agency's internal control and compliance.
