Mr. Griffin:

The Authorities Budget Office (ABO) is authorized to assist public authorities improve management practices and the procedures by which their activities and financial practices are disclosed to the public. Pursuant to Section 2800 of Public Authorities Law, state and local authorities are to make documents pertaining to their mission, current activities, annual financial reports, budgets and independent audit reports accessible to the public on the authority's official or shared web site. To assist state and local authorities meet their disclosure and reporting obligations, the ABO has issued Policy Guidance No. 10-03: "Posting and Maintaining Reports on Public Authority Web Sites." This guidance provides a checklist of policies, reports and other information that the Authority should maintain online in accordance with the Public Authorities Reform Act of 2009 (Act).

On September 7, 2016 we reviewed the Yates County Industrial Development Agency's (IDA) web site. Our review was limited to verifying that the required information is being posted on the IDA's web site. It did not address the substance of these documents. Our review focused on data for the fiscal year ended December 31, 2015. We have concluded that the IDA has not made certain required information available on its web site. Please review the attached findings and take the appropriate action so that all information required under Section 2800 of Public Authorities Law is available online and easily accessible to the public. Please provide us with a written confirmation that you have fully addressed these concerns by October 6, 2016. You may view Policy Guidance No. 10-03 at www.abo.ny.gov. Please contact us if you have any additional questions.

In addition, we noted that the IDA has not identified which board member is the IDA Chairman in its PARIS Annual Report submissions. This designation should be updated in the 2015 Annual Report and in all subsequent reports.
