**Re: Notice of Subsidiary Pursuant to Public Authorities Law § 2827-a(2)**

Dear Sirs:

Section 3555(6) of the Roswell Park Cancer Institute Corporation Act, Article 10-C, Title 4 of the New York Public Authorities Law, authorizes the Roswell Park Cancer Institute Corporation to establish subsidiary corporations in order to meet the demands of health care delivery changes and to market, manufacture or develop products of services developed by the RPCIC's clinical and research activities.

Section 2827-a(2) of the New York Public Authorities Law requires a state authority to file, no less than sixty (60) days prior to the formation of a subsidiary, notice to the Authorities Budget Office, the State Comptroller, and the State Legislature that it will be

creating a subsidiary. RPCIC herein provides the statutorily required notice by advising the addressees herein that RPCIC intends to establish a subsidiary on or after January 15, 2016 in furtherance of its corporate purpose and in order to limit potential liability of the subsidiary's operations on RPCIC consistent with subparagraphs (a) and (b) of section 2827-a(1) of the Public Authorities Law.
